II. AWARD OF BRONZE STAR MEDAL.

I. AWARD OF DISTINGUISHED-SERVICE CROSS. By direction of the President, under the provisions of AR 600-45, 22 September 1943, as amended, and under authority contained in Circular No 32, Headquarters European Theater of Operations, United States Army, 20 March 1944, as amended, the Distinguished-Service Cross is awarded to:

Private First Class Nathan Gladstein, 36036865, Infantry, 66th Armored Regiment, 2nd Armored Division, United States Army, for extraordinary heroism in connection with military operations in Belgium on 26 December 1944. The tank dozer of which Private Gladstein was a crew member was immobilized, its turret frozen and the 75mm gun useless. When the vehicle was attacked by the point of an enemy tank force and the tank commander suggested abandonment, Private Gladstein mounted the commanders' post in the turret. He manned the anti-aircraft machine gun and opened fire on the enemy. In spite of the heavy enemy small arms fire and hand grenades directed at the vehicle, Private Gladstein burned out three machine gun barrels firing at the enemy and then covered the withdrawal of the vehicle crew with a submachine gun. As a result of his action the point of the enemy force was halted and a valuable vehicle saved. The extraordinary heroism and courageous actions of Private Gladstein reflect great credit upon himself and are in keeping with the highest traditions of the military service. By direction of the President, under the provisions of AR 600-45, 22 September 1943, as amended, and under authority contained in Circular No 32, Headquarters European Theater of Operations, United States Army, 20 March 1944, as amended, the Bronze Star Medal is awarded to:
