AWARD OF BRONZE STAR MEDAL

1. By Direction of the President and under the provisions of Sec I, Cir 32, Hq ETO US Army, 20 Mar 1944, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Bronze Star Medal is awarded to:

Private EMMIT H ROGERS, 38497096, Company A, 86th Chemical Mortar Battalion, United States Army. [For heroic achievement in connection with military operations against an enemy of the United States in GERMANY. On 26 November 1944, near SCHMIDT, GERMANY, when the regular mortar crew became casualties due to intense enemy fire, Private ROGERS fearlessly manned the mortar and with utter disregard for his own safety returned the enemy fire with such accuracy that the hostile fire ceased and the enemy was forced to withdraw from his forward position. Private ROGERS' courageous actions and unflinching devotion to duty reflect great credit upon himself and the military service.

2. By Direction of the President and under the provisions of Sec I, Cir 32, Hq ETO US Army, 20 Mar 1944, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Bronze Star Medal is awarded for meritorious service in connection with military operations against an enemy of the United States during the respective periods indicated, to:

Captain ORVILLE W QUAINSTON, 01542527, Medical Administrative Corps, 32d Evacuation Hospital (Semi-Mobile), United States Army. 1 June 1944 to 8 May 1945 in the UNITED KINGDOM, FRANCE and GERMANY.

Captain KATHRYN H WILLIAMS, N703366, Army Nurse Corps, 132d Evacuation Hospital (Semi-Mobile), United States Army. 6 November 1944 to 8 May 1945 in FRANCE and GERMANY.

First Lieutenant RICHARD E FURHRMAN, 01642075, Signal Corps, 166th Signal Photographic Company, United States Army. 8 August 1944 to 6 March 1945 in FRANCE, LUXEMBOURG, BELGIUM and GERMANY.

First Lieutenant BARRON T NELSON, 01581464, Quartermaster Corps, 485th Quartermaster Refrigeration Company (Mobile), United States Army. 1 December 1944 to 8 May 1945 in FRANCE and GERMANY.

Technical Sergeant ELMERT H ARMSTRONG, 33726244, Headquarters and Service Company, 183d Engineer Combat Battalion, United States Army. 22 December 1944 to

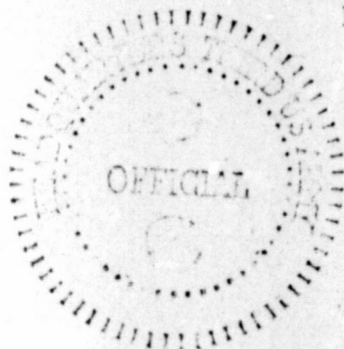
