I. AWARD OF DISTINGUISHED SERVICE CROSS.

1. By Direction of the President and under the provisions of Sec I, Cir 32, Hq ETO US Army, 20 Mar 1914, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Distinguished Service Cross is awarded posthumously to:

Lieutenant Colonel STERLING S BURNETTE, 0383615, Infantry, 1st Battalion, 317th Infantry Regiment, 80th Infantry Division, United States Army. For extraordinary heroism in connection with military operations against an armed enemy. On 11 Hovember 1944, the 1st Battalion, 317th Infantry, commanded by Colonel BURNETTE, was ettacking against fierce resistance toward the town of HAN-SUR-NIED, FRANCE. Colonel BURNETTE was with the leading elements of one of his companies that had pushed forward of the battalion in an effort to capture, intact, the one remaining bridge across the river in that sector. From his commanding position in front of the battalion, inspiring his men by his determination and bold, aggressive leadership, Colonel BURNETTE fear easly led the assault on the bridge through an intense concentration of enery artillery, small arms, mortar, and mechine-gun fire. He fell, mortally wounded, at the approaches to the bridge, but his on, inspired by his heroic example, pressed on and secured the objective. Colonel BURNETTE's conspicuous courage, heroic determination and supreme devotion to duty exemplify the highest traditions of the military forces of the United States.

Corporal JAMES A RAPINO, 33283408, Company "L", 317th Infantry Regiment, 80th Infantry Division, United States Army. For extraordinary heroism in connection with military operations against an armed enemy. On 19 September 1944, during the course of heavy action in the vicinity of BRATTE, FRANCE, Company "L", 317th Infantry, to which Corporal RAPINO was assigned, advanced to high ground isolating pockets of enemy resistance. When a formidable group of the enemy was discovered on the right flank of the company, Corporal RAPINO was assigned the mission of cleaning them out with a squad of mon. He skilfully maneuvered his squad to within grenade -throwing range of the enemy, and under his leadership four enemy mortars and three half tracks were destroyed. While returning to the company area the squad encountered heavy sniper fire. Again-Corporal RAPINO displayed conspicuous leadership by fearlessly closing with the enemy. Two enemy prisoners were taken in the ensuing action, but Corporal RAPINO suffered severe wounds which later resulted in his death. His inspirational, heroic leadership, fearless courage and supreme devotion to duty exemplify the highest traditions of the military forces of the United States.

2. By Direction of the president and under the provisions of Sec I, Cir 32, Mg ETO US Army, 20 Mar 1944, as amended by Tec I, Cir 56, Mq ETO US Army, 27 May 1944, a Distinguished Service Cross is away a to:

Major LEON D GLADDING, Chocols, Infantry, 1st Battalion, 104th Infantry Regiment, 26th Infantry Division, United States Army. For extraordinary heroism in connection with military operations against an armed enemy. On 8 December 19/4, the 1st Battalion, 104th Infantry, commanded by Major GLADDING, soized a sories of Inginot Line forts near ACHEN, FRANCE. One fort remained firmly held by the enemy, and from it fire was being directed against the left flank of the battalien, preventing consolidation of the ground gained. Major GLADDING, in an effort to reduce t fort, organized a small assault group, armed himself with a sub-machine-gun, and personally led the mon to within two-hundred yards of the enemy position. Then, while members of the group directed machine-gun and rocket fire against embrasures of the fort, Major GLADDING led four men through a barbod wire obstacle to assem't the fort itself. Standing in full Tow of the energy he demanded that the occupants surrender. Receiving no answer, he threw a phosphorus granade into one of the bunkers and courageously closed in on an adjoining bunker alone, firing his sub-machine-gun as he advanced. By the time he reached the bunker a white flag had appeared. Hineteen enemy enlisted men and one officer were thus taken prisoner and the threat of the fort removed. Major GLADDING'S heroic, inspiring leadership, courage and loyal devotion to duty exemplify the highest traditions of the military forces of the Imited States.

Sergeant WATSON W PAINE, 51145017, Company "3", 318th Infantry Regiment, 80th Infantry Division, United States Army. For extraordinary hereism in connection with military operations against an armed enemy. On 8 october 1944, during an attack upon the enemy-hold town of CLEIBRY, FRINCE, Sergeant PAINE, a communications sorgeant of one of the assaulting inf try compenies, was given a message to deliver to a plateen leader. While enroute with his message, through a heavy enemy artillery barrage, he was severely vounded in his arms and hands by sholl fragments. In spite of this he continued on, determined to accomplish his mission. While advancing, he encountered an enemy machine-gun nest that blocked his way. Unhositating, he boldly assaulted the gun and destroyed it with granades and rifle fire. Sorgeant PAINE reached the platoon which was stopped in its advance by a second enemy machine-gun. The intrepid sorgeant delivered his message and assisted the plateon leader in destroying the gun, and only ther did he call for modical aid. Sergeant PLINE displayed magnificent courago. His conspicuous horoism and suprome devotion to duty exemplify the highest traditions of the military service.

Private First Class GLENN T MARTIN, 34,576561, Cannon Company, 22d Infantry Regiment, 4th Infantry Division, United States Army. For extraordinary hereism in connection with military operation: Igainst an armed enemy. On 8 June 1944, in the vicinity of CHAU DE FONTENAY, WARCE, Company "L", 32d Infantry, was cut off from other attacking units of the regiment by strong infiltrating enemy forces. The company commander realized that in order to direct effective cannon fire against the enemy it would be necessary to call for fire upon his own position, and notified his men of the situation. Private MARTIN, a wireman with the forward observation party of the company, having full knowledge of the danger to himself, elected to remin with the party and assist in directing the supporting fire. Then the company commander was severely wounded by the friendly fire he had directed upon the position, Private MARTIN, at grave personal danger, carried him back for medical attention. Private MARTIN's conspicuous hereism and supreme devetion to duty exemp. By the highest traditions of the military forces of the United States.

Private First Class LOUIS B GREEN MERG, 32105144, Cannon Company, 22d Infantry Regiment, 4th Infantry Division, United States Army. For extraordinary heroism in connection with military operations against an armed enemy. On 8 June 1944, in the vicinity of CHAU DE FONTENLY, FRANCE, Company "L", 22d Infantry, was cut off from other attacking units of the regiment by strong infiltrating enemy forces. The company commander realized that in order to direct offective cannon fire upon the enemy it would be necessary to call for fire upon his own position, and notified his men of the situation. Private Greenberg, a radio operator with the forward observation party of the company, having full knowledge of the danger to himself, elected to remain with the group and assist in directing the supporting fire. During the ensuing action, when his company commander was seriously wounded by shell fragments, Private GREENBERG assumed the responsibility of fire direction and courageously remained at his post until the enemy withdrew. His heroic action and conspicuous courage, determination and leval devotion to duty exemplify the highest traditions of the military service.

11. AWARD OF SILVER STAR - By Direction of the president and under the provisions of Sec I, Cir 32, Hq ETO US Arry, 2) Har 19/44, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 19/44, a Silver Star is awarded to:

First Lieutenant HENRY W PLISKE, 01645288, Corps of Engineers, 168th Engineer Combat Battelion, United States Arry. For gallantry in action. During the period 17 December to 29 December 1944, Lioutenant PLISHE commanded a plateon of the 168th Engineer Combat Battalion which had been committed to action as infantry to assist in defending the town of ST VITA, BELGIUM. Lieutenant PLISKE skilfully organized and directed his plateen which inflicted heavy casualties upon the enemy, although greatly outnumbered and subjected to constant enemy artillory, small arms and direct tank fire. When, after five days of continuous action, the enemy broke through and completely surrounded the platoon, Lieutenant PLISKE, roalizing that further defense would result in capture, reorganized his men to fight their way through the enemy and reach friendly lines. Under his gallant, couragoous leadership, the men traveled by compass for eight days, covering forty-five miles of enemy-hold territory on foot, finally arriving at BASTOCNE on 29 December. The accurate information which to outonant PLISKE was ons was of great able to give regarding enemy troop movements and conceiring loadership, value for subsequent operations. His personal courag raditions of the and heroic devetion to duty are in keeping with the ha military forces of 'United atos.

3. By Direction of the President and under the provisions of Soc I, Cir 32, Hq ETO US Army, 20 Mar 1944, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Bronze Star Modal is awarded to:

Staff Sergeant ROBERT E GLEASON, 31362572, Company "A", 168th Engineer Combat pattalion, United States Army. For heroic achievement in connection with military operations against an enemy of the United States, in Belgium, from 17 December to 21 December 1914. During an intense enemy artillery barrage, a soldier of Sergeant GLEASON's unit was rendered unconscious by concussion from an exploding artillery shell. Sorgeant GLEASON, without hesitation, and with complete disregard for his own safety, aided another enlisted man in administering artificial respiration to the soldier, thus saving his life. His conspicuous courage reflects great credit upon himself and the military service.

private EDDIE L GOODWIN, 34585665, 3137th Signal Notor Mossenger Company, United States Army. For heroic achievement in connection with military operations against an enemy of the United States. The outstanding manner in which private GOODWIN performed his duties as a messenger with the 3137th Signal Motor Mossenger Company distinguishes him as an outstanding soldier. On one occasion, while traveling over a route mined by the enemy, his vehicle was wreaked by a mine and he suffered severe wounds. Despite his wourds, he removed all messages from his vehicle and proceeded on foot for three miles before receiving assistance from a passing vehicle. Private GOODWIN's determination and his loyal devotion to duty reflect great credit upon himself and the military forces of the United States.

Lieutonant Colonel DOMALD A CURTIS, 0132385, Medical Corps, 172d Medical Battalion, United States Army. For meritorious service in connection with military operations against an enemy of the United States in FRANCE from 6 August 1944 to 31 December 1944.

Lieutenant Colonel TALBOT A TUMPLESON, OL67581, Medical Corps, 167th Medical Battalion, United States Army. For meritorious service in connection with military operations against an enumy of the United States in FRANCE from 11 August 1914 to 3 January 1945.

Staff Sorgeant ALEX J SABO, 35021557, Company "A", 87th Engineer Heavy Ponton Battalien, United States Army. For meritarious service in connection with military operations against an enemy of the United States in the UNITED KINGDOM from 1 May 1914 to 30 June 1914.
