I. AWARD OF DISTINGUISHED SERVICE CROSS - By Direction of the President and under the provisions of Sec I, Cir 32, Ho ETO US Army, 20 March 1944, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Distinguished Service Cross is awarded posthumously to:

Private HARVEY L MILLER JR, 35004940, Troop D, 41st Cavalry Reconnaissance Squadron (Mechanized), United States Army. For extraordinary heroism in connection with military operations against an armed enemy in CARMANY. On 2 April 1945, when enemy forces attacked and surrounded the town of WALLENDURG, GERMANY, Private MILLER organized and led a party of six men in a spirited defense. When three of his men were killed and the remainder forced to surrender due to a lack of ammunition, he continued his gallant defense and although completely isolated at his position inside a barn, fought on against the overwhelming odds until his only exit was sealed off and he was killed. Private MILLER'S valorous, intrepid actions made possible the safe withdrawal of friendly forces from the town; his supreme devotion to duty lives on as an inspiration to the men with whom he fought.

II. AWARD OF SILVER STAR - By Direction of the President and under the provisions of Sec I, Cir 32, Hq ETC US Army, 20 March 1944, as amended by Sec I, Cir 56, Hq ETC US Army, 27 May 1944, a Silver Star is awarded to:

Technical Sergeant ARTHUR J FANCHER, 20213612, 284th Field Artillery Battalion, United States Army. For gallantry in action in CEM ANY. On 28 February 1945, Sergeant FANCHER was a member of an artillery liaison team in direct support of a Ranger Battalion when the enemy launched a fierce counterattack against their positions near OBER-ZERF, CHE ANY. With heroic disregard for his own safety, he braved enemy artillery and mortar fire to operate his radio from an exposed position and adjusted friendly artillery fire upon the enemy throughout the hour long attack. When the attack was beaten off, he braved similar hazards to establish and service the wire communications to his supporting unit. Sergeant FANCHER'S cours cous actions and outstanding devotion to duty reflect great credit upon himself and the military service.

Lieutenant Colonel LESTER C AYERS, 0241069, Infantry, Headquarters XX Corps, United States Army. 1 June 1944 to 8 May 1945 in the UNITED KINGDOM, FRANCE, GERMANY and AUSTRIA. (over)
