16. a. Upon arrival in the US MAJ EDWARD A CUSTER will report to the CG Aerial Port of Debarkation for movement to Reception Station nearest his home for further instructions and disposition. MAJ CUSTER is released fr further asgmt and dy in this theater. EXCOMR 3 Oct 45.

b. Travel by military or naval aircraft, army or naval transport, commercial steamship, belligerent vessel, aircraft, and/or rail transportation is directed. The provisions of AR 35-4820, 19 Apr 45, will apply to the O named above while traveling outside this theater.

c. A Baggage allowance of sixty five (65) pounds is auth while traveling by air. All other authorized excess and personal baggage will be packed, marked with owner's name, rank, ASN, arm and specific address in the US that baggage is to be forwarded to and will be turned over to the Effects Quartermaster for shipment by water to the US. Request for the shipment of baggage to the US will be made in accordance with INTD-SOP 45, Baggage, 1 Jul 45. The O named above will be equipped as prescribed in Cir 99, Hq European Theater of Operations US Army, 17 Jul 45.

d. Information concerning WD, army or personal activities of a military nature within this theater will not be discussed in private or public and will not be disclosed by means of newspapers, magazines, books, lectures, radio, or any other method without prior clearance through the WD Bureau of Public Relations or the appropriate Public Relations O of army installations.

e. Correspondents and publishers will be notified to discontinue mailing letters and publications until they receive notification of new address. The appropriate WD AGO Forms will be used for the above.

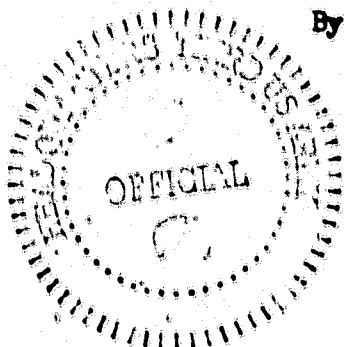

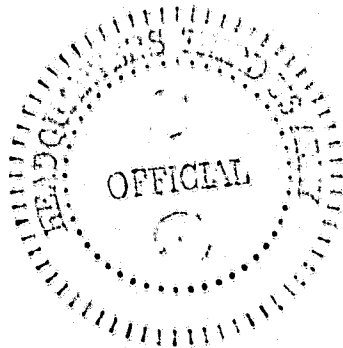
