I. AWARD OF BRONZE STAR MEDAL. By Direction of the President and under the provisions of Section I, Circular 32, Headquarters, European Theater of Operations, United States Army, 20 March 1944, as amended by Section I, Circular 56, Headquarters, European Theater of Operations, United States Army, 27 May 1944, a Bronze Star Medal is awarded for meritorious service in connection with military operations against an enemy of the United States during the respective periods indicated, to:

First Lieutenant STEPHEN T KELSEY, JR, 01012071, Coast Artillery Corps, Headquarters, 634th Antiaircraft Automatic Weapons Battalion, United States Army. 1 May 1944 to 25 December 1945 in the UNITED KINGDOM, FRANCE, HOLLAND, and BELGIUM.

First Lieutenant DAVID W MUELLER, 01111258, Corps of Engineers, Headquarters, 13th Engineer Training Group, Engineer Training Section, Army Service Forces Training Center, Fort Lewis, Washington. 22 March 1945 to 23 March 1945 in GERMANY.

Technical Sergeant JOHN J LEO, 20806512, Headquarters Battery, 634th Antiaircraft Automatic Weapons Battalion, United States Army. 1 March 1944 to 8 May 1945 in the UNITED KINGDOM, FRANCE, HOLLAND, BELGIUM, and GERMANY.

Staff Sergeant NICK F CURCIO, 36046531, Company B, 95th Chemical Mortar Battalion, United States Army. 4 April 1945 to 8 May 1945 in GERMANY.

II. DESIGNATION OF SEPARATION CENTERS.

The title of Section I, General Orders Number 22, this Headquarters, dated 14 February 1946, which reads "Activation", is changed to read "Designation of Separation Centers". So much of the above named Section as reads "the following units are designated as Separation Centers for the purpose of discharging personnel to accept civilian status as War Department civilian employees", is amended to read "the following units are designated as Separation Centers for the purpose of discharging military personnel to accept civilian employment in the European Theater".
