I. ATARD OF SOLDIER S MEDAL - By Direction of the President and under the provisions of Sec I, Cir 32, Hq ETO 'S Army, 20 March 1944, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Soldier's Medal is awarded to:

Private ROY A FENDLETON, 32609568, 238th Quartermaster Salvage Collecting Company, United States Army. For heroism not involving actual conflict with the enemy in FRANCE. The unselfish courage, above and beyond the call of duty Private FENDLETON displayed in braving the icy waters of the canal surrounding the ISIE de SAULCY, FRANCE, to rescue from drowning one of his conrades whose boat had capsized, distinguishes him as an outs onding soldier. His heroic action, without thought of his own cafety, is in keeping with the highest traditions of the military service.
