First Lieutenant LESTER J MUHLE, 01550011, Ordnance Department, \*\*\* Ordnance Ammunition Company, United States Army. For meritorious service in connection with military operations against an enemy of the United States in FRANCE from 8 November 1944 to 4 December 1944.

III. UNIT COMMENDATION - The following Quartermaster units, which were supporting the Third US Army, are commended for operation during the periods indicated:

3631st Quartermaster Truck Company (750-gallon tank),  
2 August 1944 to 12 September 1944

4003d Quartermaster Truck Company (750-gallon tank),  
2 August 1944 to 12 September 1944.

The assigned mission of these companies was to transport gasoline from pipe line terminal to supply points within the Army area. In the accomplishment of this mission, all the officers and enlisted men demonstrated an outstanding devotion to duty and a high degree of efficiency. Operating day and night without regular rest or regular meals, the men of these units delivered more than 2,600,000 gallons of gasoline during the period named and traveled approximately 775,000 vehicular miles. Such loyalty, endurance, and extreme devotion to duty denotes superior training, excellent physical conditioning, and an outstanding esprit de corps.
