SECTION II - Amendment of Section IV, General Orders No. 75,
this Hq, 21 October 1944.

I. AWARD OF BRONZE STAR MEDAL - By direction of the President and under the provisions of Sec I, Cir 32, Hq ETO US Army, 20 Mar 1944, as amended by Sec I, Cir 56, Hq ETO US Army, 27 May 1944, a Bronze Star Medal is awarded to:

Sergeant ALTON W FLY, 33101582, Cavalry, Troop "A", ** Cavalry Reconnaissance Squadron (Mechanized), United States Army. For meritorious service in connection with military operations against an enemy of the United States in France from 2 September 1944 to 14 September 1944.

Corporal JOHN E PARKER, 7008552, Cavalry, Troop "B", ** Cavalry Reconnaissance Squadron (Mechanized), United States Army. For meritorious service in connection with military operations against an enemy of the United States in France from 1 August 1944 to 21 August 1944.

Corporal WINFRED HAYES, 7008549, Cavalry, Troop "A", ** Cavalry Reconnaissance Squadron (Mechanized), United States Army. For meritorious service in connection with military operations against an enemy of the United States in France from 1 August 1944 to 22 August 1944.

Technician Fifth Grade JOHN W BURDET, 7008588, Cavalry, Troop "A", ** Cavalry Reconnaissance Squadron (Mechanized), United States Army. For meritorious service in connection with military operations against an enemy of the United States in France on 4 August 1944.

Private DONALD E BATTIS, 7008592, Cavalry, Troop "C", ** Cavalry Reconnaissance Squadron (Mechanized), United States Army. For meritorious service in connection with military operations against an enemy of the United States in France from 3 August 1944 to 20 August 1944.

II. AMENDMENT OF SECTION IV, GO NO. 75, THIS HQ, 21 OCT 1944 - So much of Sec IV, GO No. 75 THIS Hq, 21 Oct 1944, as awards a Bronze Star Medal to Sergeant LEE DONALD, 7001585, Cavalry, is amended to read as follows:


